The department of French bloomed in the year 1968 in order to give students the opportunity to learn a foreign language. Students from various discipline choose French as Part I French Course for undergraduate degree programme. It is the only college in Knayakumari district providing Part I French in aided stream.

St. Mary's College (Autonomous), Thoothukudi (SECOND PARTY) is a Catholic institution of Higher Education for women, run by the Congregation of Mother of Sorrows, Servants of Mary (Servite Sisters), was established in 1948. PURPOSE OF THIS MEMORANDUM OF UNDERSTANDING

- (a) The provisions of this MoU are intended to describe the manner and extent to which the Parties will work together.
- (b) The MoU records the current level of Association between the Parties and is a record of their intentions in respect of the issues described in this MoU.
- (c) The Parties agree that the MoU is not contractually binding and that this MoU does not impose any legal liability or obligation on each Party or their respective employees, contractors, agents and advisers.

TERMS OF THIS MEMORANDUM OF UNDERSTANDING

- (a) This MoU shall become effective from the date of signing by both the parties. It shall remain valid for **THREE YEARS** with the understanding that it may be modified by written mutual consent of both parties.
- (b) Either PARTY may terminate this Agreement with the advance written notice of one month upon notice of termination.
- (c) The agreement may be extended by mutual consent of the two parties after three years and it may be renewed in writing.
- (d) **FIRST PARTY** and **SECOND PARTY** agree in principle to maintain confidentiality of all matters, under the purview of this MoU.
- (e) **FIRST PARTY** and **SECOND PARTY** will hold mutual consultation regarding any matter relating to the terms of this MoU and will jointly function with a spirit of Cooperation and Mutual Trust .
