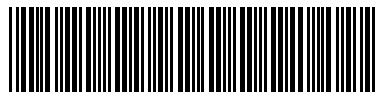

- Phase - III will consist of Personal Interview. The final selection will be based on the performance in the Main Examination (Phase II) and Interview (Phase III).
- Choice of language for Interview: Hindi/ English.
- Please download and completely fill the bio-data cum attestation form (no column should be left blank) which is available on SBI Careers Website. Please take 4 photocopies of the completely filled bio-data form, paste your recent photograph at the space provided on all the five forms and place your signature across the photographs so that it covers partly the photograph and the bio-data forms. One set of self-attested photocopies of required certificates should be attached with the original bio-data form. The original bio-data form and its four copies have to be submitted at the time of reporting for the interview. Please note that you will not be permitted to participate in interview (Phase – III) unless you submit completed bio-data form, with a complete set of copies of certificates at the time of reporting for Phase III. - Photograph captured at the time of online main examination will be verified. You are advised not to change your appearance till the process is completed.
 - IRIS captured at the time of online main examination will be verified. Decision of the IRIS verification with regard to its status (matched or mismatched) shall be final and binding upon the candidates. Refusal to participate in the process of IRIS verification on any occasion may lead to cancellation of candidature. With regards to the same, please note that candidates should remove Contact Lenses and Spectacles while capturing IRIS. Candidates are advised to avoid wearing contact lenses and prefer spectacles.
 - For Visually Impaired candidates, verification of Biometric right thumb impression captured at the time of online main examination will be done. In terms of recent GOI guidelines, the candidate will also be required to sign a declaration to the effect that he/ she does not belong to the 'Creamy Layer' for availing reservation under OBC category on the prescribed format at the time of interview.  - Wherever applicable, the documents confirming date of discharge from Army/ Navy/ Air Force, particulars of rank last held and details of your medical category.  - Persons with Disabilities (PWD) will have to produce a medical certificate in the format from the authority as specified in the RPWD Act of 2016 in support of his/ her disability. The certificate should be dated on or before **05.10.2021**.
 - Service Certificate(s) in respect of your present/ previous employment(s).
 - Character Certificates issued by any two of the following:

8. Persons in the service of Government/ Public Sector Banks/ Undertakings, have to submit a "**No Objection Certificate**" from their employer at the time of appearing in interview (Phase III of the selection process). 




