We refer to your application and subsequent selection process. We are pleased to inform you that, you have been provisionally selected for admission to the one-year Post Graduate Diploma in Banking & Finance (PGDBF) offered by our partner Manipal Global Education, as per the criteria and terms of selection specified on the Bank's website / advertisement notification. **The Course will commence from 20.11.2023.**

2. Upon successful completion of the said course as stated in para 9 herein you will be recruited in Bank of India for the post of CREDIT OFFICERS AS GBO - JMGS-I in Junior Management Grade/Scale-I.
3. Your admission will be subject to:
 - a) Your fulfilling the prescribed eligibility criteria i.e. prescribed age as on 01.02.2023 and basic educational qualification as mentioned in our Notice dated 01.02.2023.
 - b) You being found medically fit and certificate by Bank's Doctor
 - c) Submission of following documents / certificates in original alongwith -3- sets of photocopies duly attested: -
 - i. Govt. issued Photo-identity proof viz. Aadhaar Card with a photograph/ passport / Driving license / PAN Card/ Voter's Card
 - ii. Certificates in support of educational qualification from SSLC / Matric onwards viz. Class Xth marksheet, Class Xth School leaving certificate (containing Date of Birth), Class XIIth pass certificate, Class XIIth marksheet, Graduation degree / provisional certificate, marksheets for all the graduation years/semesters and final consolidated marksheet (if any), Post-Graduation / Technical and Professional qualification certificate along with marksheets for each year / semester.
 - iii. Caste / Community certificate issued by the Competent Authority in the format prescribed by the Government of India, in case you belong to SC / ST / OBC category.

Another 2 photographs will be required, if availing educational loan.

- f) The above referred certificates / documents submitted by you shall be deemed to be material for the purpose of this admission. 4. **Academic requirements:** The one-year Full Time Post Graduate Diploma course at Manipal Academy of BFSI is divided into -2- distinct phases viz. a -9- month programme on the Campus of Manipal Academy of BFSI, Bengaluru, followed by -3- months of internship at a Bank of India branch at any place in India. The 9-months on-campus programme is further broken down into 3- trimesters (3 months each).
5. **Campus:** Manipal Academy of BFSI is fully residential with separate blocks for an academic wing as well as blocks for hostels (males/females) with all necessary amenities provided therein.

A separate welcome email will be sent by Manipal Academy of BFSI to candidates joining the program with details of contact person, **do's and don'ts at the campus** etc.

Basic medical assistance will be available on campus. A doctor would be available at appointed hours in the campus besides being on call on a 24 by 7 basis. The hostels are located inside the campus.

6. **Uniform:** A specially designed uniform has been prescribed for all the students admitted to this course and it is compulsory to be in uniform while in class hours. The uniforms will be provided by the Bank for this purpose for which you will be required to inform the specific size / measurements after reporting at the campus to enable for procuring the uniforms and handing over the same to you.
7. **Stipend:** All students admitted to this course will be eligible for receiving a lump sum amount of stipend from the Bank as per the amount mentioned below:
During -9- months on Campus period - 2500/- per month.
During -3- months internship at BOI branch - 15000/- per month.
8. **Maintenance of Discipline:** You will have to abide by all the rules and regulations of the Manipal Academy of BFSI, rules of the hostel, etc. and ensure good conduct and discipline as laid down during your tenure with the School. The hostel rules, regulations, guidelines for discipline, etc. of Manipal Academy of BFSI, which you will have to abide by and adhere to at all times is given in the student handbook. Breach of any of the rules of discipline and conduct as laid down will be dealt with seriously and may even lead to termination/disqualification.
9. **Successful completion of the course:** Successful completion of the course will have to be in terms of fulfilling all the academic requirements, including required attendance, passing of papers / attainment of credits, etc. as stipulated by Manipal Academy of Higher Education (MAHE) and no exemptions, whatsoever, will be permissible in any case. **Kindly note that all papers of all -3- trimesters need to be necessarily passed within the one year course duration only. Upon completion of your eligibility verification, medical examination and clearance from the respective Zonal Office mentioned above about your fitness for admission to the course, you will have to complete the fee payment process, as outlined below.

12. **Course Fee:** The Fee for the above said PGDBF course of one year is Rs. 3,50,000/- + GST which shall be paid by you as per the following schedule

The aforesaid course fee of Rs.3,50,000/- (Rupees Three Lakh Fifty Thousand only) plus GST includes fee for the in-person classroom and computer lab facilities, advanced library facilities, residential accommodation on sharing basis, all boarding facilities (breakfast, lunch, dinner). 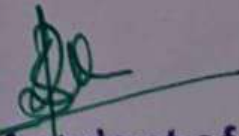

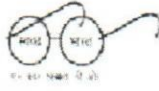

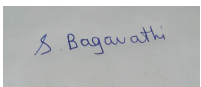
